Task # 2: Please prepare written answers to the following quiz questions based on the video.

The judge considers the chances the person will attend future court appearances, the protection/safety of the public and confidence in the administration of justice.

4. What does the word "recognizance" mean?

The person charged with a crime is released after promising, in writing, to appear in court for all upcoming proceedings. The written promise is the recognizance.

5. What does the word "surety" mean?

A surety is a person who takes responsibility for another's performance of an undertaking, for example their appearing in court.
