
#### Please take note

For example, a tenant who shares a kitchen or bathroom with the owner or a close family member of the owner might not be covered.

### Moving out (pages 2-3)

Learners can begin by looking at the picture and talking about what they see. If you have access to an digital projector, you may want to project the picture without the title, so that learners won't be distracted by making the connection between moving and the content of the picture.

When you introduce the title, you may wish to begin by explaining that "moving out" means leaving one place to live in a new place. Elicit what learners know about moving – why people move, what they need to do when they move, and who they need to tell. Explain that when tenants move, they need to tell their landlords, and there are rules about how to do this. Sometimes tenants who don't follow the rules have to pay rent for some of the time after they move. Tenants who are moving need to tell their landlords in writing and on time.

In the story, Maria fills out a form. This form is based on part of the Landlord and Tenant Board's Form N9, Tenant's Notice to Terminate the Tenancy. The form is available from the website <a href="https://">https://</a> tribunalsontario.ca/ltb/forms/.

Note that in the story Maria gives her form personally to her landlord. If Maria mailed her notice, she would need to send it by September 24, to allow 5 extra days. Tenants should keep a copy of the notice they give to their landlord, and they should make a note on it of the date they delivered it and how they delivered it. These days many tenants like to email their notices. Emailing notices is possible, but only if: a) The tenant has the landlord's permission to talk with them this way, and b) The tenant signs the notice (an e-signature is acceptable).

# How many days? (page 4)

Go through the calendar activity as a class to ensure comprehension. This activity helps learners understand the importance of giving notice on time. "On time" is usually at least 60 days before the tenant's moving date, and **the moving date must be the last day of a rental period or term**. \*Please note: The choice of moving date is very important. In the example in the activity, if Maria gave December 1, 2021 as her moving date, she could be liable for an extra month's rent.

#### Answers:

# Maria's letter (page 5)

This is a reading activity. Explain that Maria can write a letter if she can't get the form soon enough. Please note: It is best to use the Landlord and Tenant Board's Form N9 to give notice, but it may not always be possible. It is more important to give notice on time than to use the correct form, provided the notice contains all the essential information and is signed.
