- [Pro Bono Ontario free legal hotline](#): 1-855-255-7256; up to 30 minutes of free legal advice each call, covers topics related to housing, employment, consumer protection and debt, going to court, powers of attorney
- [Ontario Legal Information Centre \(OLIC\)](#): offers free 30-minute consultations with lawyers. The lawyers do not provide advice but offer legal information and referrals. Consultations are online or by phone in English or French. There is no income requirement.
