
Newcomer Legal Clinic

ESDC - Economic & Social Development Canada



Needs Identified, Specific to Northern Ontario

- Limited support for complex issues
- Currently ancillary service
- Challenge of navigating portals when not a lot of supports on ground who are familiar with the processes
- Clients end up going to Winnipeg to get what they need
- All specialized clinics are located in the GTA, not fully aware of what is going on out here, and not accessible to clients
- Linguistic barriers
- Clients experience forced migration because of displacement from their own land

Our Goals

- 1. Fill the access to justice gap for migrants and refugees in Northwestern Ontario
- 2. Build community knowledge about migrant and refugee rights and processes
- 3. Train people to serve newcomers, including lawyers

Who We Serve

We provide services to migrants, refugees, and people without status in our catchment area.

This includes:

- Foreign workers and students
- Expired status
- Facing removal from Canada
- Refugees and claimants
- Sponsoring Family

How We Help

- Information and advice for people with immigration, refugee, or citizenship law questions
- Ongoing guidance and support
- Representation:
 - paper applications
 - Immigration & Refugee Board, Federal Court
- Connecting people with reliable lawyers and representatives here and in other cities
- Referring to local agencies

<u>Changing Migration Landscape In</u> <u>Northern Ontario</u>

- Thunder Bay wants to attract 50,000 newcomers by 2041 (<u>NOSWPB</u> <u>Report 2025</u>)
- Non-permanent residents make up over 100% of Northwestern Ontario's population growth (<u>NOSWPB Report 2025</u>)
- New immigration programs targeted at Thunder Bay
- End of Rural and Northern Immigration Pilot leaving smaller communities in Northern Ontario in the lurch
- At the same time, increased immigration enforcement, border securitization



Eligibility Criteria

• Living in Northwestern Ontario

Low-income or other barriers

 Issue related to immigration, refugee, or citizenship law

What we consider when deciding eligibility

- Income and assets (similar to community legal clinic thresholds)
- Can client access help they need elsewhere?
- Precarious employment
- Geographic isolation
- Discomfort with or limited access to technology
- Disability, health, mental health issues
- Expressed need for local support
- Experiences of racism or discrimination based on immigration status when trying to access local services
- Other barriers identified by the client or referring partner
- Does need fit with clinic priorities?

Needs we prioritize

- Resettled refugees trying to reunite with family, especially if complex
- Migrant workers dealing with abuse
- People dealing with domestic violence
- People in isolated communities throughout the region
- Intersections with other areas of law
- Facing removal, procedural fairness letter, dealing with refusal of an immigration application
- Services for which the client LAO certificate eligible but cannot find a certificate lawyer willing to work with them remotely (there are no immigration/refugee empanelled lawyers in our region)
- Advice to people seeking family reunification under IRCC public policies for emergency situations (Gaza, Sudan, Ukraine)



What We Explain To Clients...

- We do not administer immigration programs
- Confidentiality (unless req'd to disclose by law)
- Do not share information with the government unless instructed by client
- Serve our clients' interests
- Believe that access to justice and legal processes should be free and equal
- Services guided by an **ethic of care** and ensuring government treats **migrants and refugees according to law**



Immigration Legal Services

Why does Northern Ontario need regional immigration and refugee legal services?

- Increased government efforts to limit migration and enforce removals
- No IRCC office located in Northern Ontario (Winnipeg or GTA)
- Need identified are unique to Northern Ontario



What about LAO Certificates?

Certificate Available

- Refugee claims
- Pre-removal risk assessments
- Temporary resident permits for victims of family violence
- Detention (Ref Law Office duty counsel)

Certificate NOT available

- Family reunification for refugees and others
- Abused migrant workers
- Out-of-status remedies (depending on situation)
- Citizenship applications
- Work permits and study permits for refugee claimants





Migrant Worker Support Program



<u>Migrant Workers Support Program</u>

The aim of the program is to:

- Provide information and support to exercise rights
- Increase migrant workers' awareness
- Foster inclusion of migrant workers in the community
- Support migrant workers during emergency situations
- Develop coordinated approaches to supporting migrants in the community



Who are Migrant Workers?

- Anyone in Canada on a temporary work permit tied to their employer
 - Cannot work for any other employer →
 employer hold significant power over worker
 - Worker might be depending on abusive
 employer to stay in Canada → delicate situation
 - Employer might also be landlord → housing

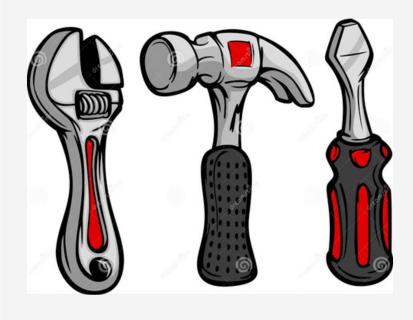

NEWCOMER LEGAL CLINIC

OWP-VW Eligibility

- Be inside Canada,
- Have an employer-specific work permit that is still valid (has not expired yet),

AND

 Have been abused or are at risk of abuse by your employer.



Employment Protections for Foreign Nationals Act (Ontario)

- Recruiters cannot charge fees to workers
- Employers cannot charge for hiring costs
- Recruiters / employers cannot take property or documents
- Workers cannot waive their rights
- Workers cannot be punished for exercising rights (reprisals)
- Can complain using the Employment Standards Act process



<u>Migrant Workers Support Program</u>

ie. requesting condition changes, assisting with family work and study applications, assisting with providing legal information and referrals to other legal services.









What to do if you suspect employer abuse

- Consider referring to Newcomer Legal Clinic
- There are options for reporting the employer worker might want to seek immigration advice first
- Worker might want to consider:
 - Human Rights claim
 - Claim under Employment Standards Act



WHO ARE WE

- The **Thunder Bay Multicultural Association** was formed in **1972** by a number of various community ethnocultural groups whose objective was to establish a body which would encourage and facilitate co-operation among ethnic organizations in promoting the concept of multiculturalism.
- In **1987** TBMA bought the old Court Street Fire Hall which was built in **1906**.
- TBMA is now the only newcomer settlement agency that provides services geared towards immigrants and refugees within Thunder Bay and NWO region.
- Offers information, orientation, and referral services.
- On-site Language Instruction for Newcomers to Canada (LINC) classes.
- NWO Local Immigration Partnership is hosted in TBMA

WHY TALK ABOUT LEGAL STRUGGLES?

- Legal systems in Canada are complex and culturally specific
- Newcomers face barriers to understanding rights and laws
- Misunderstandings often lead to serious outcomes
- Frontline workers often act as the bridge between systems and people



COMMON LEGAL STRUGGLES AMONG NEWCOMERS

- ✓ Child protection & cultural differences
- Family and domestic issues
- ✓ Mental health and justice involvement
- ✓ Housing and employment exploitation
- ✓ Immigration paperwork
- ✓ Access to legal aid and interpreters
- Examinations for driver's licences
- ✓ Cultural, racial, & gender discrimination



2. Scenarios & Legal Themes FACED BY NEWCOMERS





Scenario 1

A family is reported to the CAS because their home had no furniture and only carpets. The family is investigated which causes fear in the parents and the children involved.

How would cultural competency help in this situation?



Cultural Misunderstanding with Child Protection

BIAS IN ASSESSMENT



Client is getting evicted, because there are too many people living in their apartment. They inform you that they are nervous because they are not allowed to work in their current situation.

What follow up questions could help determine if this is related to immigration status?



When it comes to immigration status and housing:

- Inform them if they are worried about their immigration status, to contact us or an immigration lawyer or registered immigration consultant.
- Landlord and Tenant issues are not something immigration law covers, it will still be a referral to a legal clinic who practices housing law.
- Check if their housing is tied to their employment, if so, refer to NLC.



An LGBTQAI2+ newcomer faces cultural community discrimination. Their health issues get publicized, and they are afraid of reporting it, due to a fear of it affecting their citizenship application.

What information would you provide to this person?



Gender and Sexual Identity Discrimination

A woman who was financially and emotionally abused lost her opportunity for sponsorship. Her Spousal sponsorship application got stalled because they separated. She left Canada because she thought she was not allowed to stay.

Do you think that leaving Canada was her only option? If so, why? If not, why?



What if a decision-maker tells people they must leave Canada?

- Errors are common in the administration of the immigration legal system
- People being told to leave Canada often need and want legal advice if they want to stay
- Please refer to us!



A woman chooses to remove her hijab and seek more independence after moving to Canada. Their spouse reacts violently, and the police get called and the children get taken away after the incident.

What services do you think they need?
What if you can't communicate with them in their language?

A refugee claimant just arrived to Dryden three months ago from Syria. They applied for OHIP, but they keep getting their OHIP application denied.

Transition Points

Transition

What is happening?

Extension of temporary status

- application to extend status filed before expiry of current status
- status usually maintained until new decision made

Out of status to temporary status

- application is pending (restoration or temporary resident permit)
- applicant does not have status until approved

Temporary resident or out-ofstatus to permanent resident

- waiting on PR status
- if temporary resident, apply to extend or maintain status
- can be a risk to leave Canada seek legal advice

PR to citizen

waiting for invitation to oath of citizenship


