Who we are

Legal Aid Ontario (LAO) is a board-governed agency of the Ontario government.



Our scope of services

LAO is one of the largest providers of legal aid services in North America, delivering high quality and cost effective services in English and French to almost 1 million low income and frequently highly vulnerable clients each year.

How we are funded

LAO is primarily funded by the Ministry of the Attorney General (MAG), and receives additional funding from the federal government (for criminal and immigration & refugee law services), the Law Foundation of Ontario (LFO) and client contributions.



Our role in the justice system

LAO services are essential to the efficient operation of the justice system and we are a key partner in justice sector recovery initiatives.



Funding for entity service providers

LAO provides funding to 71 independent legal clinics, 3 Indigenous legal services organizations and 8 student legal services organizations throughout the province who specialize in clinic law and assist vulnerable Ontarians in accessing legal services.

LAO's mandate

- We promote access to justice by providing high-quality legal aid services that are efficient, effective and accessible.
- Our principles in s.17(2) of the <u>Legal Aid Services Act, 2020</u> state that legal aid services should:

Promote access to justice

Be efficient, effective and high-quality

Be provided in a clientfocused, innovative, transparent and accountable manner

Be responsive to the needs of low-income individuals and disadvantaged communities in Ontario

Promote early resolution, where appropriate

Be co-ordinated with other aspects of the justice system and with community services

LAO's financial and legal eligibility criteria

An individual applying to receive legal aid services must meet both:

LAO's financial eligibility criteria

 Their income and assets must fall within the financial eligibility thresholds set out in LAO's governing rules.

LAO's legal eligibility criteria

 Their legal issue must be one that LAO covers.

Financial eligibility thresholds (FET)

LAO recently implemented an increase to its FET for duty counsel services and criminal certificate services. Eligibility requirements are:

Considerations for Indigenous clients

Self-Identification	Financial eligibility thresholds	
 When individuals apply for legal aid or receive duty counsel services LAO will ask if they self identify as First Nation, Métis or Inuit. This allows LAO to ensure that their lawyer knows that they are Indigenous and can apply the law properly, including explaining Gladue rights and rights under Indigenous child protection laws. 	 LAO excludes monies received from Indigenous settlements from its financial eligibility test. This includes monies received from class actions, including but not limited to: Sixties Scoop settlement Residential school settlement Day school settlement Drinking water advisory settlements Jordan's principle and treaty settlements

First instance decision-making to expedite service in urgent matters and for vulnerable groups is a priority in all access channels. Follow-up may be required.

Intake services are offered in over 300 languages, including TTY and 18 Indigenous languages and dialects.

If clients have difficulty finding a lawyer, LAO staff are available in local courts and regional offices to provide in-person assistance in connecting people with services.



LAO also has staff lawyers who provide certificate services via LAO's Criminal Senior Counsel Program, Family Senior Counsel Program and Family Law Services Centres.









Privacy and consent

- LAO operates under the guidelines of Ontario's Freedom of Information and Protection of Privacy Act (FIPPA). This means LAO must comply with FIPPA when collecting, using, and disclosing personal information.
- Consent and declaration (C&D) forms are signed by applicants who want to receive LAO's certificate services.
- The purpose of a C&D form is to create an agreement between an applicant and LAO about how they will work together.

By signing the C&D form, applicants are granting LAO permission to:

- Examine their financial information to make sure they are eligible to receive LAO's services.
- Examine information related to their legal proceedings so LAO may better understand and assist with their case.
- Share information with their lawyer.

By signing the C&D form, applicants are also showing that they understand:

- They have certain responsibilities as a recipient of LAO's services (like providing the correct information and following LAO's processes).
- The cost of their court proceedings and the cost of the legal aid services that LAO provides will be handled in a specific way depending on their case.
- They cannot make electronic recordings of their interactions with LAO staff without permission.

LAO can assist individuals if:

- They have been charged with a crime that could send them to jail if they are found guilty; and
 - They qualify financially.

LAO maintains a list of lawyers who are up to date on issues affecting Indigenous clients.

Family law services

LAO can assist individuals with:

- Navigating matters in *Child, Youth and Family Services Act (CYFSA)* proceedings and under any Indigenous law created pursuant to Bill C-92: *An Act respecting First Nations, Inuit, and Métis children, youth and families.*
 - Determining or changing decision-making responsibility, child support, and/or parenting time/contact with their former partner.
 - Resolutions through mediation or negotiated settlements.
 - Preparing court documents and representing them at court.
 - Obtaining a restraining order in cases of domestic violence.

Pre-litigation services

LAO provides pre-litigation certificates for parents in child protection matters or for proceedings under a First Nation child protection law (Bill C-92).

These certificates include having a lawyer to assist in negotiating a customary care, voluntary care, or temporary care agreement, or to facilitate participation in an Indigenous alternative dispute resolution process.

- Assist with bail (consent releases, hearings).
- Assist with resolutions (diversion, pleas).
- Assist with resolution negotiations (CPTs, JPTs).
- Assist clients in Case Management Courts.
- Assist clients in specialty courts (mental heath court, Indigenous peoples court, drug treatment court, youth court).
- Legal advice and disclosure review.
- Onsite services at detention centres.
- Public Legal Information and referrals to other agencies.

Family duty counsel

Family duty counsel

- Assist with CYFSA matters (place of safety and status review).
- Assist with emergency motions (without notice).
- Assist with document preparation (motions to change).
- Assist with case/settlement conferences.
- Provide advice and information through Family Law Information Centres (FLICs).
- Assist with Family Responsibility Office matters (first appearances and adjournments).
- Public Legal Information and referrals to other agencies.

- Information about separation, divorce and child protection
- The Ministry of the Attorney General's Guide to Family Procedures
- Court forms and information about court processes
- Referrals to family mediation services connected with the court
